

New Broadcast Come into

NTO 2.0 to be effective next FY

Mumbai: The Telecom Regulatory Authority of India (Trai) has extended the deadline for the implementation of the new broadcast sector tariff regulations — commonly known as NTO 2.0 — from December 1, 2021, to April 1 next year.

The new channel and bouquet pricing for consumers will take effect on April 1, 2022, according to the revised schedules.

Broadcasters must submit their reference interconnect offer (RIO) by December 31, which includes the MRP of their channels and bouquets, as well as other interconnect agreement terms and conditions.

Broadcasters who have already published RIOs in accordance with NTO 2.0 can update and submit fresh RIOs before the end of the year.

Meanwhile, by January 31 distribution platform operators (DPOs)—DTH and cable companies — must disclose their distributor retail pricing (DRP) of channels and bouquets, as well as other information.

Trai has given DPOs time between February 1 and March 31 to receive consumer requests for subscriptions to channels of their
